PRESIDENT'S REPORT 26TH September 2021

It is with pleasure that I present the President's Report of the South Arm Peninsula Men's Shed Inc. for the year 2020-2021.

In my last year's report I expressed hope that a "Shed" would be constructed by now. I may have been overly optimistic but did not anticipate the delays that have blighted our progress towards achieving our aim. At this stage we still do not have the Council lease in place, hence other permits cannot be granted. Funding likewise has been difficult to obtain although we are optimistic that a current application will be successful.

Over the past year I have gained a greater awareness of the value of community sheds and so I have become increasingly frustrated with the obstacles we have had to overcome in our journey. The expressed support for a "Shed" in our community has been enormous; not only locally but at Municipal, State and Federal level. Unfortunately all too often this spoken support is not manifested in practical terms but only pays lip-service to our needs.

We have done everything possible to progress our cause and I have become increasingly annoyed by the reference to "The Process" as the reason for delays. There are over 60 "sheds" in Tasmania and they individually have their own problems, but at least they have a "Shed"! We appeal to all those Councillors, Politicians and others who are in a position of influence to get behind us to help get a shed built.

Despite the lack of progress on the one hand our community remains solid in its support. Our membership has grown beyond 100. Our funding exceeds \$30 000 and with a promised \$53 000 from State Government we are well on our way. Money raised locally is the result of hard work by our members and strong community support, both individuals and businesses. A quiz night and 'open mike' evening at the Touch of the Mo not only raised valuable funds but helped publicise our cause. Our many market stalls have also helped to publicise our plans and have attracted both interest and financial support.

Our committee has worked tirelessly to progress the steps required to achieve various permits and approvals. Additionally they have been extremely active in gaining fundraising opportunities. I would encourage anyone with time to spare to give their support to any of the fundraising activities we will undertake in the future. We have worked hard to keep members informed through our newsletters so it is easy to know when events occur.

While there has been some delays in our journey, I and my committee remain solid in our endeavour to provide this much needed facility for our community. We know we will get there but must wait for the 'Process' to take its course.

I wish all our members the very best for the forthcoming year. Please continue with your support so our community gets the facility it deserves.

Report on the financial report

Oct 2020	Aurora Energy Community Grant \$9,800 for planning costs Unsuccessful
Jan 2021	Stronger Communities Round 6 \$20,000 for stage one construction footings and slab. <i>Unsuccessful</i> – advice was that we were not eligible as the project would not result in a community benefit. (A slab alone is of no use to the community)
March 2021	Building Better Regions (BBR) Round 5 \$80,000 to match our own available funds (current and future). Results expected Sept 21 have been delayed due to excessive applications to the fund (double the usual). <i>Challenges</i> – high number of applications, \$ for \$ funding. Still waiting to hear.
March 2021	Request to council for consideration for Men's Shed funding in their 2021-22 infrastructure budget, \$55,000. <i>Unsuccessful</i> , due to budget constraints.
April 2021	Letter to Jacquie Petrusma re State Government support \$53,000 to make up our share of BBR funding <i>Success</i> - Paperwork started to secure these funds into our account
Sept 2021	 Tas Community Fund Infrastructure (TCF) Two stage application Stage 1 - EOI for \$80,000 to round our existing funds available EOI results due Oct 2021, Stage 2 - if successful we get to lodge a full application and make a presentation to the board. Final outcome due Dec 21. Challenges – in Feb 2021 TCF staff advised us that a Council contribution may be required for our application to be considered. Highly competitive funding, 10 x available funds applied for last year.
